



- I. Year-end report
 - A. Confirmation of BoD application notification sent to membership
 - B. Registration
 - 1. 145 total teams: 77 B and 68 C with 14 new teams (11 B; 3 C) from 9 schools

2. Trends (2020 data from Scilympiad registration data):





3. Per WSO Spring 2020 meeting vote, all teams that did not compete would have waived 2020-21 registration fee. Teams that competed would get a \$100 discount/each 2019-20 registered team. Breakdown sent to WSO Board. Questions about whether to offer discounts to teams that COULD have competed, but didn't (some based on school/district restrictions; some not following up with tournament; some based on lower #s of

students competing due to parent restrictions). This affected 7 teams – not sure if worth getting documentation of [valid] reason. Coaches were apprised of waived/discounted 2020-21 fees in March and will be provided with updated info prior to the start of 2020-21 registration.

C. Performance

 Only SW and Eastern B Div at BBCC were able to compete due to COVID-19, resulting in 36 competing teams and 107 non-WA-competing

D. Finances

- 1. Savings
 - a) Balance \$34,962.60
 - (1) less \$1744.01 earmarked for EWSO = \$33,218.79 available for WSO
 - (2) Includes \$3,321.23 unused funds from South Central Region ... didn't add in with contributions, but could be!
 - b) Contributions \$4,070.54
 - (1) includes \$2400 from SPEEA grant
 - (2) \$1,650 from Microsoft matching contribution
 - c) Interest \$27.26
 - d) There is also about \$650 in the UW SO savings account I could return. This is cash from WSO we didn't spend. I believe UW SO owes WSO about that much because we had to get bailed out in 2017 (?)

 - (1) extra \$ end of year due to refunds from COVID (\$3,714.69) plus NW tournaments not using allotted funds.

One new school ecstatic to participate! Tournament officials were happy with outcome and anxious to return 2020-21. Recent contact with tournament directors indicate they are not in a position to set up a tentative tournament date for 2020-21. [Jay can address in more detail, as needed.]
 - b) 3/14/20 Spokane Community College B-C Tournament was less than 1 day from proceeding when cancelled. WSO support payment has been returned. Spokane Falls Community College

has reserved facilities 3/13/21, obviously with expectation that COVID restrictions have been lifted AND SFCC has budget to accommodate.
