- I. Call to Order 9:02 AM PDT
- II. Roll Call (see above)
- III. Approval of minutes from 1/22/22 meeting.
 - A. Minutes approved without objections

- IV. Reports
 - A. Treasurer
 - 1. Checking:
 - a) Balance: \$2912.08
 - b) Revenue (complete for FY22): \$22,657.62 that includes \$17.27 extra "income" from PayPal/PP due to change in fee structure
 - c) Expenses to date: \$23,343.30 ... only anticipated expenses thru FY22: State Director pay for May/June (\$1,000) + WA State Charities application (\$40) + monthly Zoom of \$16.20
 - d) WSO Tournament Expenses paid to date: \$15,892.98 that should cover all tournament expenses with exception of tournament director (TD) compensation. Per prior msg, hoping George can be compensated for hours/time/effort he put in to making the regional and state tournaments a success. A total of \$29,700 was approved for WSO tournaments. Previous request that board to consider/approve compensation of \$2500/tournament [allotted in budget] for \$5,000. [Will be addressed as separate item.]
 - 2. Savings:
 - a) Balance: \$29,557.92 (\$1,744.01 earmarked for eastern WA) = \$27,813.02 for WSO*
 - b) Donations: \$468.79
 - c) Interest Income: \$4.38
 - d) *SW WSO is in planning stages for moving regional funds from Clark College to WSO ... so far, not completed
 - B. State Director
 - Regional & State Tournaments completed successfully. Some issues, but mostly related to teams not totally understanding or abiding by virtual tournament policies. Congrats to tournament coordination team – amazing job! George's contribution was above/beyond. Awards ordered at nationals that will send directly to teams. This completes 2022-23 season chores.
 - 2. All team payments rec'd and transferred from PP to checking, along with donations to WSO and purchase of state T-shirts which Judy facilitated. WSO total cost was \$3,776 (compared to up to \$10,000+ normal cost).
 - Have rec'd 3 BoD apps & 2 Student Advisor apps by 4/30 deadline, so despite membership vote, we will have 3 BoD positions filled & 2 Student Advisor positions.
 - C. Regional Boards
 - 1. Eastern
 - a) Sue has reached out to SFCC tournament site, hasn't heard back.


- b) Jay reports no new updates with Big Bend Sue or Jay will reach out.
- 2. Northwest
 - a) Scott reporting on previous conversations with Clean Energy Institute and their interest in supporting WSO tournaments and solar-related events (Solar Power, Solar Vehicle), and CEI may be able to provide graduate students to support
 - (1) Possibly involves some modifications with national event rules to make WA-specific, and CEI may have budget to support that

- V. Old Business
 - A. Tournaments debrief
 - 1. Regional
 - a) 105 teams (about evenly split across divisions)
 - b) Sue sent out order for medals to national vendor, 4th place ribbons went out to E and SW regions, 7th/8th place for NW was not received in time so did not go out in same batch
 - 2. State
 - a) 52 teams (evenly split across divisions)
 - All details directly related to tournament are posted to <u>https://scilympiad.com/wa</u>, anticipate no further changes to the page
 - c) Sue sent out order for medals to national vendor, sent out ribbons including regional ribbons for NW
 - d) Judy put out order for t-shirts which teams/volunteers, just approved proof from shirt company, should expect to receive maybe a week from now, and she sent gratitude gift cards (\$20) to volunteers
 - e) Alumni survey sent out to teams, a few students have indicated interest in helping WSO
 - 3. Reflection on virtual tournaments
 - a) David mentions possibly carrying over some virtual oncomputer events into in-person tournaments
 - b) Scott reports students reported virtual tournaments as a "grind," but virtual videos were a useful learning tool
 - B. Outstanding tournament items
 - Action: George to finish sending out volunteer gratitude messages received from participants/coaches
 - 2. Action: Sue to post regional and state scores to WSO website
 - C. International Community School (ICS) appeal of EDQ from state tournament
 - 1. Judy's summary: 2022 State ICS Food Science Appeal.pdf
 - 2. Team was placed on Annual Warning (AW) after EDQ, and on notification of AW elected to appeal AW

- 3. Team had ~8 hours to submit printed resources, follow-up emails in reply to initial request didn't address actual notes
- 4. Judy motions to keep EDQ, seconded by Jay, on voting decision to keep EDQ as is is unanimously supported by board
- Action: Outcome of vote and EDQ standing to be sent to coaches of ICS
- 6. Was not policy this year Judy thinks if ever repeating virtual format in future, should have some guidance on answers that are plagiarized directly from sources/notes as does not seem to promote proper learning and instead just copy/pasting
- 7. Tanya: "Plagiarism is hard for grad students to avoid. So I think we need to give grace to middle and high school students that it is most often a mistake but certainly teachable moment."

VI. New Business

- A. 2022 Board of Directors election
 - 1. 3 board members applicants for 3 board member seats
 - a) 1 from NW, 1 from SW, 1 from E
 - 2. 2 student advisor applicants for 2 student advisor seats
 - a) 2 from SW (Camas)
 - 3. Sue to send out ballots but all applicants expected to be elected
- B. Tournament Director compensation
 - Due to extraordinary measures taken to conduct virtual regional and state tournaments, motion to award \$5000 tournament director stipend to George Sun made by David Rosi, seconded by Judy Mannard.
 - a) Motion passed unanimously.
- C. Visioning
 - 1. Rekindling relationships with host sites for in-person
 - a) Sue reports Eastern region will be uphill battle, NW region will probably have more support with larger number of teams
 - b) Opportunity to (re)consider hosting at high schools and middle schools
 - c) David trying to keep things rolling in SW with LCC, trying to keep outside involvement growing but regional schools continue to play important role with supporting tournaments
 - d) Financial hurdle for many sites is cost of custodial fees
 - e) Tanya reports Senthil might be able to facilitate possibly having WSU Spokane host
 - f) Argument that students attending tournament matriculate to host site college/university doesn't work well as numbers don't support it (experience from Seattle Central and Highline)
 - g) Enthusiasm for virtual Science Olympiad is waning, impression mostly previously participating students just continuing with the program

- h) Revisiting traditional practices for in-person tournaments
 - Educational resources from Science Olympiad, Inc. have been the same for the last 10 years, still contain typos
 - (2) Scott suggests revisiting coaches clinics
 - (3) Nick mentions Project Lead the Way (PLTW) as a curriculum that many schools are adopting, can advertise Science Olympiad as an activity that meets requirements for PLTW
 - (a) Skills USA is the group the engineering PLTW



- 2. Volunteer/alumni engagement
 - a) Cleaning up volunteer database, adding new volunteers/alumni from this year
 - b) Involving out-of-state alumni/volunteers on test review committees
 - Action: David to help exporting tests from Scilympiad for 2021–2022 season
 - Action: Diana has tests from 2020–2021 season, George to follow up and get the folder of tests from her
 - e) Test writing committee that is used across state with invitational, regional, and state tournaments, with focus on the community experience with writing tests
 - f) Judy at Highline had continuity in volunteers from regional to state and used test review committee, positive feedback from coaches on test quality for those tests
 - g) Support for continuing coordinating test efforts across regions
 - h) Revisiting discussion on breaking tournaments into multiple tiers of teams (like A and AA that some states use)
 - Proposal to national organization for communication system for Event Supervisors from across country to coordinate among each other
